Respectfully, I hereby invoke and refuse to waive all of the following rights and Privileges afforded to me by the U.S. Constitution:

- My name and date of birth are written below; accordingly, I have provided law enforcement with all
 of the information that I am legally obligated to provide.
- I invoke and refuse to waive my <u>Fifth Amendment</u> right to remain silent. Do NOT ask me any questions.
- I invoke and refuse to waive my <u>Sixth Amendment</u> right to an Attorney of my choice. **Do NOT ask**me any questions without my attorney present.

Flip Over: Con't \rightarrow

- I invoke and refuse to waive all privileges and rights pursuant to the case <u>Miranda v. Arizona</u>. Do
 NOT ask me any questions or make any comment to me about this decision.
- I invoke and refuse to waive my <u>Fourth Amendment</u> right to be free from unreasonable searches and seizures.
- I do NOT consent to any search or seizure of myself, my home, or of any property in my
 possession. Do NOT ask me about my ownership interest in any property. I do NOT consent to this
 contact with you. If I am not presently under arrest or under investigatory detention, please allow me
 to leave.
- Any statement I make, or alleged consent I give, in response to your questions is hereby made under
 protest and under duress and in submission to your claim of lawful authority to force me to provide
 you with information.
- I wish to contact my lawyer immediately, and pursuant to ARCrP Rule 4.2, I invoke my right to contact him without undue delay if I am being detained, arrested and/or placed in secure custody.

What to Do

Stay Calm and In Control! Have pen and paper out.

Only \underline{Crack} Your Car Window – enough that you can hear them and they can hear you – enough to hand them your ID, this card, insurance, etc.

Respectfully, <u>Invoke Your Rights.</u> Use sir or ma'am, if you must speak. "Sir, I Choose to Remain Silent". Don't just wait, ask, "Sir, Am I Free to Go?" "Sir, I DO NOT Consent to any Searches." "I Want to See My Lawyer."

If the officer continues to ask you questions, "Sir, what is your name and badge #?" Write everything down.

When an Officer asks you to do something, always come back with, "Are you asking me, or are you ordering me?" If the officer is evasive, ask again. An officer who orders sufficient movement through a show of authority may cause a <u>de facto arrest</u>, which can be unlawful absent probable cause. (Leads to potential suppression of evidence and civil remedies).

Record everything (video and audio). Passengers, "I choose to remain silent; I do NOT consent to search."

If contraband is in plain sight, this allows them to search you or your car without a warrant.
